Tie Down Permittees at both SBP and L52 Airports are currently not required to submit proof of insurance to the County.

For all other aircraft space rental applicants / permittees, please submit your proof of insurance pursuant to the following:

Please refer to the insurance requirements below. We suggest that you provide your insurance broker / agent with a copy of these requirements and request that they provide Certificates of Insurance with copies of the Endorsement for Additional Insureds. ISSUANCE OF YOUR PERMIT CANNOT PROCEED WITHOUT THESE DOCUMENTS.

Permittee shall procure and maintain for the duration of the Permit, insurance against claims for injuries to persons, or damages to Property, which may arise from or in connection with Permittee's operation or use of the Assigned Space/Hangar or Airport. The cost of such insurance shall be borne by Permittee.

1. CERTIFICATE OF INSURANCE (COI) FOR AIRCRAFT LIABILITY INSURANCE:

Minimum Insurance Coverage and Limits

Aircraft Liability Insurance providing coverage for bodily injury and property damage including premises liability and liability for damage to non-owned hangars with a combined single limit of not less than \$1,000,000 per occurrence, including not less than \$100,000 per passenger limit.

Deductible and Self-Insured Retention

Any deductible or self-insured retention must be declared by PERMITTEE to and approved by Director and the COUNTY Risk Manager.

2. ADDITIONAL INSURED ENDORSEMENT:

- Additional Covered party: The County of San Luis Obispo, CA, its officers, employees and agents are added as additional insured parties with respect to operation of the named insured at, or from, the County Airport or the Assigned Space/Hangar occupied and used by the named insured pursuant to the Permit issued by the County.
- > **Endorsement** must include reference to the **Policy Number** and the **Insured** as they appear on the Certificate.
- ➤ **Primary Insurance:** The Endorsement must state that the coverage afforded by this endorsement shall apply as **Primary**. Other insurance maintained by the County shall be excess only and not contributing with the insurance provided under this policy.
- ➤ Waiver of Subrogation: Permittee hereby grants to County a waiver of subrogation which any insurer of said Permittee may acquire against the County by virtue of the payment of any loss under such insurance. Permittee agrees to obtain any endorsement that may be necessary to affect this waiver of subrogation, but this provision applies regardless of whether or not the County has received a waiver of subrogation endorsement from the Insurer.
- Effect of Failure of Refusal: If Permittee fails to procure or maintain the insurance required by this Permit, or fails to furnish the County with the certification required above, County shall have the right, as its option, to forthwith terminate the Permit.

3. CANCELLATION LANGUAGE:

Each insurance policy required above shall provide that coverage: shall not be suspended, voided, canceled, reduced in coverage or in limits except after thirty (30) day's prior written notice by mail has been given to County. Cancellation of coverage for a non-payment of premium will require thirty (30) days written notice to the COUNTY Airport. The thirty (30) day written notice is not required if the Permit is terminated and the aircraft is immediately removed from the Airport, or if the aircraft is sold and immediately removed from the Airport.
